AFFIDAVIT FOR ARREST WARRANT

Your affiant has been a police officer for the past 27 years. Beginning in 1991 your affiant worked in the Crime Against Children's Unit with the Lakewood Police Department. For the past 11 years, your affiant has worked as an investigator with the Jefferson County District Attorney's Office, assigned to the Crimes Against Children's Unit. Since October of 1996, your affiant has also investigated individuals who utilize the Internet to seek children for the purposes of having sex with them.

During the week of August 7, 2006 Detective Jaclyn Shaklee of the Fort Collins Police Department was involved in an online Internet sting hosted by the Denver Police Department at the Safe Streets Task Force in Denver, Colorado. During the sting, Detective Jaclyn Shaklee portrayed herself as a [REDACTED] using a Yahoo screen name. Detective Jaclyn Shaklee was sitting idle in a Colorado Chat room when she was contacted by [REDACTED]. [REDACTED] exchanged instant messages and Detective Jaclyn Shaklee told him she was [REDACTED] years old and he responded that he was 52 years old. Soon after their first chat, Detective Jaclyn Shaklee added [REDACTED] to her Friend's List and he started appearing to her under the friends list as "scott cortelyou" and a small photo of a man in a business suit appeared next to his name.

Cortelyou asked Detective Jaclyn Shaklee for a picture which I did not provide.

On August 8, 2006 Detective Jaclyn Shaklee contacted Cortelyou and early in their chat, Detective Jaclyn Shaklee reminded him that she was [REDACTED] years old. He asked Detective Shaklee's persona if she had sex before and that he wishes he could have more sex. Cortelyou said he "plays [REDACTED]" and it feels good. He asked Detective Jaclyn Shaklee ever played with it and if she got "wet." Cortelyou said "guys squirt" when they are done.

During this chat, Cortelyou told Detective Jaclyn Shaklee he works in "communications sort of" and owns a 1966 Mustang. Detective Jaclyn Shaklee was able to corroborate that Scott Cortelyou works for Radio Colorado Network hosting "Business for Breakfast" and has a 1966 Mustang that lists to him.

Cortelyou then educated Detective Jaclyn Shaklee on masturbation and an excerpt of the chat is as follows:

scott cortelyou (8/8/2006 8:50:12 AM): you fondle it til it gets h ard..then stroke it back and forth
UC Screen Name (8/8/2006 8:50:31 AM): wow
UC Screen Name (8/8/2006 8:51:06 AM): that sond kewl
scott cortelyou (8/8/2006 8:51:44 AM): its even better if you can get someone else to do it for you..or suck it
UC Screen Name (8/8/2006 8:52:12 AM): how do w hand.
scott cortelyou (8/8/2006 8:52:21 AM): yes
scott cortelyou (8/8/2006 8:52:34 AM): but [REDACTED] are better

UC Screen Name (8/8/2006 8:52:48 AM): y beter
scott cortelyou (8/8/2006 8:52:56 AM): dunno..just feels better
UC Screen Name (8/8/2006 8:53:00 AM): kewl
scott cortelyou (8/8/2006 8:55:30 AM): ever seen a hard [REDACTED]?
UC Screen Name (8/8/2006 8:55:59 AM): in pic
scott cortelyou (8/8/2006 8:56:06 AM): never touched one?

Cortelyou further told Detective Jaclyn Shaklee how to masturbate and an excerpt is as follows:

scott cortelyou (8/8/2006 9:28:33 AM): ever slide your finger in?
UC Screen Name (8/8/2006 9:28:55 AM): no that hurt wnt it
scott cortelyou (8/8/2006 9:29:13 AM): not all the way..just a little. and not the hole you pee thru..the other bigger one
UC Screen Name (8/8/2006 9:29:43 AM): the one i pooh thru ewwww
scott cortelyou (8/8/2006 9:29:50 AM): no...between the two
UC Screen Name (8/8/2006 9:30:07 AM): ohhhhh kewl
scott cortelyou (8/8/2006 9:31:17 AM): wiggle a finger in there a little..and get it wet
UC Screen Name (8/8/2006 9:31:34 AM): rt now?
scott cortelyou (8/8/2006 9:31:45 AM): sure.you alone?
UC Screen Name (8/8/2006 9:31:59 AM): yea
scott cortelyou (8/8/2006 9:32:06 AM): k..go ahead if you want
UC Screen Name (8/8/2006 9:32:12 AM): k
scott cortelyou (8/8/2006 9:32:36 AM): then i tell you about aanother place to rub
UC Screen Name (8/8/2006 9:32:53 AM): k
scott cortelyou (8/8/2006 9:37:45 AM): fnd the hole?
UC Screen Name (8/8/2006 9:38:16 AM): giggles
scott cortelyou (8/8/2006 9:38:20 AM): cool
scott cortelyou (8/8/2006 9:38:46 AM): ok..just above the hole..kinda hidden.is a little bump like thing..called the clit...see if you can find that
UC Screen Name (8/8/2006 9:39:06 AM): k
scott cortelyou (8/8/2006 9:39:31 AM): when you find it..rub it in little circles..soft touch though
UC Screen Name (8/8/2006 9:39:39 AM): k
scott cortelyou (8/8/2006 9:41:44 AM): feel good?
UC Screen Name (8/8/2006 9:42:04 AM): it difrnt
scott cortelyou (8/8/2006 9:42:39 AM): you can rub it faster and harder if you want..helps if you dip your finger back into the hole now and then to get it wet
UC Screen Name (8/8/2006 9:42:58 AM): k
UC Screen Name (8/8/2006 9:47:27 AM): wow i lik tht
scott cortelyou (8/8/2006 9:50:34 AM): cool.
scott cortelyou (8/8/2006 9:50:46 AM): its even better if you can get someone [REDACTED] for you

Cortelyou then told Detective Jaclyn Shaklee it is better if "a friend" can help with this process and asked if Detective Jaclyn Shaklee had ever been "[REDACTED] down there."

Cortelyou logged off of Yahoo Messenger from work, **143 Union Boulevard Suite 780, City of Lakewood, County of Jefferson and the State of Colorado** and logged back on when he got home, [REDACTED] **County of Jefferson and the State of Colorado**. He said his wife was at work and he was at home "rubbin it." He told Detective Jaclyn Shaklee she could do it as well and that he bets it is "pretty" because "[REDACTED] are pretty." He then asked if Detective

Jaclyn Shaklee had a web cam. He then told Detective Jaclyn Shaklee he had "squirted" and was finished and then logged off.

On August 10, 2006 Detective Jaclyn Shaklee saw Cortelyou was logged onto Yahoo Messenger and Detective Jaclyn Shaklee said "hi" to him. He said he was looking for "some [REDACTED] today." He said he sometimes meets people in person that he chats with on line but has not met young girls because it's "illegal." He told Detective Jaclyn Shaklee he is glad she wasn't near where he is because he would be "tempted."

Cortelyou then told Detective Jaclyn Shaklee to "get naked" and if she was hot and they would chat later about what to do when Detective Jaclyn Shaklee was naked.

During the Denver sting from August 7, 2006 and August 11, 2006, Kristina Bomba with Colorado Bureau of Investigations requested a photograph of Cortelyou from the Department of Revenue. Detective Jaclyn Shaklee was able to identify Scott Cortelyou (DOB: [REDACTED]) as the same male in the photo next to Cortelyou's name in Yahoo Messenger.

Fort Collins Police continued the investigation when they got equipped for online investigations in October of 2006. The investigation continued from October 20, 2006 until Cortelyou was arrested on January 23, 2007.

The above information was given to me by the Lead Detective in the case who is a sworn Police Officer with The Fort Collins Police Major Crimes Unit. She has been a sworn officer for 8 1/2 years and a detective for approximately 2 years.

On January 23, 2007, Detective Jaclyn Shaklee and your affiant interviewed Cortelyou after he was advised of his rights, and acknowledged and waived his rights agreeing to talk with us. During this interview Cortelyou admitted to talking online from both his work and home.

Based on the aforementioned facts, your affiant believes that sufficient evidence has been presented for Internet sexual exploitation of a child, 18-3-405.4, and requests a warrant be issued for Scott Eller Cortelyou, Date of Birth, [REDACTED], described as a white male, 5'11" tall, 185 pounds, Grey hair, and Blue eyes. Cortelyou's last known residence is [REDACTED] Conifer, County of Jefferson and the State of Colorado.
